





OAP is mauled by relative's XL bully

Man, 73, rushed to ARI with serious facial injuries after dog attack



XL bullies face tighter regulation.

AN ABERDEEN pensioner has suffered severe injuries to his face, arms and hands after being mauled by a relative's XL bully.

The 73-year-old man was attacked by the male dog named Gunna when he went to check on

his family member's pets while the owner was on holiday.

The OAP is in Aberdeen Royal Infirmary after receiving surgery following the incident at a property in Dyce on Wednesday.

Police said a 70-year-old woman was also taken to hospital.

Gunna's owner Jack Watson, 22, said the attack came as "a very big shock" for his family and that his dog will be destroyed.

He said: "It's a nightmare that I thought would never happen."

A person who has not previously served as Commander may be required by the Lord Lyon to serve a five or ten year term as Commander before the Lord Lyon would be prepared to assign the Chiefly Arms to that person.

Individuals wishing to put themselves forward as a candidate for Commander or Chief of Clan Strachan are also encouraged to come forward. A candidate must bear the surname alone and must be proposed and seconded by a Strachan authorised to attend the Family Convention. Self-nomination is permitted. This does not mean a new candidate will be appointed Chief immediately. If a new candidate emerges, the Lord Lyon, may insist they serve for a period as Commander. The convention's decision is subject to the Lord Lyon's approval. The Clan Strachan Society cannot favour
